

Terms & Conditions "Give your pocket a break!"

PO Box 363865 Telephone (787) 273-5000; (hereinafter referred to as the "**COLGATE or SPONSOR**"), through its non exclusive Distributor, Massy Distribution (Guyana) Inc., D4 Starlite Square, East Coast Demerara Telephone 592-220-8198, hereinafter "**MASSY**" or "**ORGANIZER**") makes available to the general public the following Rules of the Promotion "Give your pocket a break!" (hereinafter will be called "**THE PROMOTION**");

Article 1: Object of the PROMOTION:
